Description of how your charity's programs helped achieve your purpose:

The PHCC continued to deliver quality environmental projects to the value of 4.06 million in 2019/20. The PHCC delivered major projects focused on improving water quality, conservation and biodiversity and community education and awareness. We also delivered projects and programs including supporting an increased number of landholders with technical and financial support (grants). Our second year of our Community Environmental Grants was well oversubscribed and reflects the successful structure of supporting applicants throughout the process. We have increased a focus on improving capacity and capability for Noongar employment and long term benefits to our Noongar community and played a major role in the development of the application for a Winjan Ranger Program, which was successful. We continued to support NRM practitioners and community through targeted learning support, where resources allow. We continue to support community Landcare and other groups to secure funding via multiple sources for on-ground and community engagement activities (environmental), including engagement with Noongar community in planning and design. Our Program Manager, Waterways and Science position has enabled continued interaction and support for school and community citizen science programs and evidence based land management. We held the first of our annual Wetland Weekenders which was very successful against our community education and awareness goals. We are actively progressing new partnerships and projects with a focus on industry, expanding our value across the catchment. We delivered as contracted against year 2 of 12 million tender with the Australian Government, to deliver specified environmental outcomes against 5 Work Orders, despite covid-19 impacts and constraints. We commenced an agreement with the Perth Zoo supporting the Numbat Breeding Program, and the Black Bream project with John Tonkin Children continues to inspire our community. We have secured an additional Work Order from the Australian Government (for protection of Black Cockatoos). Our presence in the upper catchment continues to grow. We are continuing to diversify our income sources through new agreements/MOU's with industry and local governments, in an attempt to reduce financial risks.
